

Steps to Register Online for VBS 2019

1. **Download** the **VBS Registration pdf** attachment to your computer from the First Christian Church website. www.fcctillamook.org/vbs-registration.html
 - Save the VBS Registration attachment onto your computer's desk top or a desired file folder.
 - Make a note of where you saved the file so you can open the file on your computer.
 - If you try to use the file on the FCC website, it will not work. You must make a copy of the file on your own computer first.

2. **Open** the VBS Registration PDF file with **Adobe Acrobat**
 - Go to the file folder where you saved the PDF file of the release form.
 - Click (or double click if needed) to open the file with Adobe Acrobat. Most computers have Adobe Acrobat loaded; if not, it is free from Adobe (www.adobe.com). Also, please make sure that it is the most current version of Acrobat. Some of the older versions of Acrobat or PDF viewers from Apple or other places may not function properly, so please make sure it is Adobe Acrobat.

3. **Fill out** the VBS Registration Form
 - Please type your information into each space provided. Use the drop down menus where provided.
 - The VBS Registration form is designed to automatically fill in information that is repeated. If you make a change in one of the repeated input areas, it will automatically change in the other areas.

4. **Save** the Registration Form
 - **This is very important!** Make sure you save the VBS Registration Form separately for each child who will be attending Athens VBS 2019.
 - A **"Save" Button** is located on the form. Please have the file name be:
VBS Registration 2019 name of child.pdf
 - For Example: VBS Registration 2019 Tammy Lee.pdf
VBS Registration 2019 Carrie Lee.pdf
 - If you save the VBS Registration Form separately for each child attending VBS 2019 and email them, we will have a printed VBS Registration Form ready for you to sign on the first day of VBS.

5. **Email** the VBS Registration PDF file back to VBS19@fcctillamook.org
 - Please email and attach **Each Child's** VBS Registration PDF file that you have filled out.
 - Print a copy of the VBS Registration for your own record.
